The Principal shall verify and certify the affidavits submitted by the candidates receiving the grant directly to their bank accounts (annexure II) and other eligible candidates availing fee concession receiving the grant through the institution's bank account (annexure I) who have not remitted the examination fee during registration.

Fee payment can be made through SBI Collect/ Treasury Challan. The candidates who receive the grant directly to their bank account shall remit the fee amount to the University as and when it is received from the Government Department concerned. Fee in respect of candidates availing fee concession received through the institution's bank account shall be credited to the Kannur University Fund and details of such remittance shall be informed to the Examination Branch without delay. If any candidate receiving grant through the institution's bank account has remitted the examination fee during registration, the College shall reimburse the amount to the candidate.

*Penalty will be levied for delayed submission/incorrect submission/ non-submission of data/Applications, as per the university rules.*

Candidates with shortage of attendance will not be issued hall tickets unless the Principal recommends and states that the shortage is within the condonable limit and the application for condonation have been forwarded to the Registrar.
