NOTIFICATION

It is notified for information of all concerned that the M.Phil. Final Examination, 2019 for all faculties will be held as follows:

(i) Last date of submission of fees and forms from the Department concerned to the office of the Controller of Examinations –

Without Late fine: on or before 29.04.2019 With Late fine: latest by 03.05.2019

- (ii) Last date of submission of Dissertation Paper by the P.G. Department(s) to the A.P. Section of the Controller of Examinations' Department: **by 28th June, 2019.**
- (iii) Examination fees:
 - (a) Rs. 1600/- (one thousand six hundred) only per examinee
 - (b) Last submission [up to three (03) months, i.e., on and from 1st July, 2019 to 30th September, 2019] of dissertation paper may be allowed on submission of "Delay Submission Fees" of Rs. 1500/- (Rupees one thousand five hundred) only in addition to usual examination fees on or before 27th September, 2019 stating the justified reason(s) and with the recommendations of the Supervisor(s) following the existing regulations.
- (iv) Relevant Sections of the M.Phil Regulations as approved by the Executive Council in its meeting held on 06.02.2018 (vide Item No. 285) are cited below for taking necessary action:
 - (a) **U.E.Reg (M.Phil -1):** The entire M.Phil Programme of studies shall be divided into four Semesters in two years as per the relevant approved syllabi.
 - Semester-I and Semester-II Examinations will be held in the first year of the Programme which is termed as the <u>Course Work Examination</u> of the Two years M.Phil Programme.
 - Semester-III & Semester-IV Examinations will be held in the Second year of the Programme which is defined as the Final Examination of the M.Phil Programme and only the candidates who pass the Course Work Examinations i.e. Semester-I and Semester-II Examinations can only be entitled to appear in the Final Examination of the Second Year of the Programme on compliance with the conditions as stipulated in the relevant regulations.
 - (b) **U.E.Reg (M.Phil -23):** (1) The Post-graduate Board of Studies concerned shall approve a Panel of three experts who are not in the employment of the University/College affiliated to this University and who have their expertise on the relevant field of research work, for appointment as examiners of each Dissertation Paper by considering the list to be submitted by the Supervisor concerned.
 - (2) A Board of Examiners, consisting of the Supervisor and one External Expert shall be appointed by the Hon'ble Vice-Chancellor from the relevant panel.
 - (c) **U.E.Reg (M.Phil -24):** Public Viva-voce of a research scholar to defend the dissertation as stipulated in the original regulation shall be conducted only if the evaluation report of both the examiners on the dissertation are satisfactory and

- include a specific recommendation for conduction the viva-voce examination of the same and the Supervisor concerned will fix the date of viva-voce in consultation with the Head of the department concerned and external expert concerned.
- (d) U.E.Reg (M.Phil -25): After the successful completion of the viva-voce of dissertation paper of the respective examinee(s), marks will be awarded to the respective candidates jointly by the internal supervisor and external expert on the basis of the performance of both the dissertation evaluation (out of Full Marks 150) and viva-voce examination (out of Full Marks 50) and the same will be sent to the department of Controller of Examinations in a closed envelope for finalization of results.
