NOTIFICATION

It is notified for information of all concerned that the following decisions have been made by the appropriate authority in connection with form fill up of ensuing B.A./B.Sc./B.Com. Part III Examination, 2017

- 1. Candidates bearing Roll Prefix 14 who appeared at B.A./B.Sc./B.Com. Honours/General Part-II Examinations, 2016 but failed to secure qualifying marks (Q) for appearing at the Part-III Examinations, 2017 under existing regulation be allowed to appear at the Part-III (Final) Examinations, 2017 along with their failed (back) subject(s)/Group(s) of subjects at the Part-II Examinations, 2017 provided the candidates have secured "Q" (i.e., obtained qualifying marks in all subjects) at their Part-I Examinations and subject to other terms and conditions as laid down here under;
- 2. Candidates bearing Roll Prefix 15 having failed subject(s)/Group(s) of subjects in Part-I and/or Part-II Examinations be permitted to appear at their Part-III Examinations, 2017 along with their back subject(s)/Group(s) of subjects in Part-I and/or Part-II Examinations in the year 2017 as and when would be held provided they fulfil all other conditions as laid down in the relevant regulations and subject to other terms and conditions as laid down here under:
 - i) The photocopies of mark sheets of both Part-I and Part-II examinations (last attended) of such candidates must have to be submitted at the time of submission of filled in examination form along with draft DR to the university.
 - ii) The candidates appearing at REPEAT EXAMINATION at any stage (i.e., Part-I/Part-II) must not be allowed to appear at the Part-III examination in the same year. If any deviation is detected in any stage regarding availing of both the benefit as in above by the examinee, his/her benefit, if any, in the REPEAT EXAMINATION will not be considered for finalization of his/her result in Part-III examination in the same year and be treated as cancelled without assigning any reason.

The Principals/Teachers-in-Charge of all colleges are requested to take positive measures so that no candidate be allowed to fill up their examination forms both in REPEATEXAMINATION (at any stage, i.e., Part-I &Part-II) and Part-III Examinations.

- iii) The results of Part-III (Final) examinations, 2017 of such candidates be published along with other candidates of Part-III examinations of 2017 as PNC, Le, concerned Part-I/Part-II not cleared and their mark sheets will be issued accordingly. No appeal from the examinees be considered for finalization of their results at Part-III level before publication of their relevant failed part(s) of examination(s).
- iv)The results of those candidates who will not qualify their Part-I/Part-II examinations even after re-appearance will be published as PNC, Le., Part-I/II not cleared and their mark sheets will be issued accordingly.

- v) The candidate who after retaining credit marks in all subjects (i.e., Honours/General/Group of subjects and ENVS) at the Part-III examinations, subsequently qualifies his/her Part-I and/or Part-II examination(s), as the case may be, availing the prescribed chances as per relevant regulations, will be declared to have qualified /passed the Part-II/part-III (final) examination(s) in the year in which he/she qualifies in his/her Part-I/part-II examination(s).
- 3. It is further decided that the candidates bearing Roll Prefix 16 who will fail to secure qualifying marks at part-I and part-II examinations to appear at part-III examinations in the year 2018 and onwards will not be allowed to appear at part-III examination along with failed/back subject(s) in Part-I or Part-II examination(s) in the same year and the existing regulations in this respect be followed strictly.
