In case you fail to turn up and record your presence by signing between 10:00 a.m. to 11:00 a.m. (sharp) on 3rd July 2018, your claim for admission will be forfeited.

You are required to deposit

- i) A demand draft of Rs. 500/- towards **counseling processing non refundable fee** in favor of the Registrar, Gurukula Kangri Vishwavidyalaya, payable at Haridwar (*cash will also be accepted*)
- ii) A Demand draft of Rs. 60000/- towards **Admission fee** at the time of counselling, in favor of the Registrar, Gurukula Kangri Vishwavidyalaya, payable at Haridwar (*However you may deposit Rs. 60000/- by cash also*)

- i) Fee should be deposited immediately after the admission is granted. If you **fail to deposit the fee** within the prescribed time on same day, your **admission shall be treated as cancelled** and
