### Instructions to the Candidates:

1. The Candidates have to submit a xerox copy of the memo of marks of qualifying examination along with their application forms.

3. *Late fee Rs.1,000/- will be imposed for according late permission to the Candidates after the due date. No application will be entertained after the commencement of exams.*
4. The appearance in the examinations by the candidates will be subject to eligibility and promotion norms. They will forego the results of the Exams appeared in deviation of norms.

1. Ascertain the eligibility of the Candidates before uploading their forms and submission of NRs. Forward the applications of only eligible candidates. If any deviation found, College will be penalized @ Rs. 20,000/- per each deviation as per the norms.
