Xerox Copies of Examination Application Forms & photographs will not be considered.

The Principals are requested to verify the examination forms and eligibility of the candidates and forward same to the Controller of Examinations, Osmania University by **02.02.2017** positively, along with the Nominal Roll (in duplicate). Fee abstract statement required about the payment of Examination fee.

Not to collect the Exam fee from Blind, Physically Disabled, Deaf & Dumb students as per O.U Order No. 1555/228/2007-08/Budget-V, dated: 25-03-2008. A Xerox Copy of Medical Certificate confirming their status as Handicapped (minimum percentage of disability must be of 40%) must be attached to the Application forms. Blind, Physically Disabled, Deaf & Dumb Students Application forms should be submitted separately along with Separate Nominal Roll.

The University has decided to accept the payment of Examination fee through Core Banking system from the colleges under Osmania University Jurisdiction as communicated vide. Lr. No.171207/COE/2007, dated 17.12.2007. The Core Banking system has come into **effect from 01.04.2008** onwards.

No Demand Drafts are accepted at core Banking section at Exam Branch

Further after remitting the Examination fee into Registrar, Examination Fee Fund Account through Core Banking system the College can obtain a receipt from the Bank and submit the same to the Examination Branch along with Examination Forms.

The College is required to enclose the clearance certificate issued by the stores section of the Examination Branch as a proof for the unused examination stationery returned by the college pertaining to the examinations conducted earlier.

The candidates appearing for B.Ed. III Semester Examinations are advised to enclose the xerox copies of B.Ed. I & II Semester Memo of Marks.

Fee paid once cannot be refunded or adjusted for any future examination.
