The Second Counselling for admissions to the first year of MBBS / BDS courses based on the merit / rank list of NEET(UG)-2016 as started from 23.09.2016 vide Advertisement No. BCECEB(BCECE)-2016/30 Dated 21.09.2016 was cancelled vide Advertisement No. BCECEB(BCECE)-2016/32 Dated 24.09.2016 due to reason explained therein. The same has been Rescheduled and will now start from 28.09.2016 at 9.00 A.M. in I.A.S. Building, Near Patna Airport, Patna-800014 for which the candidates who are successful and qualified on the basis of NEET (UG)-2016 against State Quota MBBS / BDS seats for Bihar and who have applied Online for participating either in First Counselling or in Second Counselling in response to Adv. No.-BCECEB(BCECE)-2016/22 Dated 25.08.2016 and 2016/27 Dated 10.09.2016 are eligible.

2. Each candidate eligible as per para 1 above has to appear in Second Counselling on the rescheduled date alongwith downloaded hard copy of already 'online' filled part-A and filled Part-B of the application form, Merit rank sheet for 2nd counselling which can be downloaded from Board's Website the original certificates & documents and other required enclosures. After verification of certificates / documents/ identity, of the candidates, course / institution will be allotted merit / rank wise to eligible candidates as per prospectus of UGMAC-2016.

UGMAC-ID and merit rank sheet for second counselling can be downloaded by visiting the Boards Website www.bceceboard.com and clicking on the link "UGMAC-2016 MERIT FOR SECOND COUNSELLING" after entering the candidates UGMAC-ID & Date of Birth.

3. The candidates who has taken admission against Bihar Quota seats on the basis of 1st Counselling held from 04.09.2016 to 06.09.2016 and applied for change of institution in prescribed proforma in their respective Colleges are required to attend 2nd Counselling as per programme given below alongwith their state merit rank card for 2nd Counselling downloaded from Board's website and bonafide certificate in prescribed proforma issued by concerned institution.

- 4. After seat allotment and receiving of seat allotment letter the candidates has to take admission same day in BCECE Board office itself. Hence candidates are directed to come fully prepared with all necessary and required documents and also a cash of Rs. 10,000/- [Ten thousand] (approx). The final amount will be made known to the candidates at the time of admission. In case additional amount is needed, they have to deposit it in the concerned college on the date given by the Institution.
- 5. The Institutions concerned has already been informed for coming BCECE Board office with all preparation for taking admission. Hence all concerned Principals are directed to come with their admission team on 28.09.2016 i.e. start day of 2nd Counselling.
- 6. The UGMAC-2016 reserve category candidates who competed in General category have been included in General as well as their respective reserve categories. Such candidates of General category will be allowed to exercise their option of Institution / Course against seats available in their respective reserve categories also. Therefore, reserve category candidates who are included in General Category must come for counselling on the date fixed for the same at their General Category merit serial otherwise reserve category seats may be allotted to candidates of lower merit and for this they themselves shall be responsible.
- 7. All the certificates included in the list given below, if applicable, must be submitted in original by every fresh candidate at the time of his/ her Counselling / Allotment on the rescheduled date:
 - i. Original Admit Card of NEET(UG)-2016.
 - . Passing Certificate / Marks Sheet / Admit Card of Matric / equivalent Examination.
 - iii. Passing Certificate / Marks Sheet / Admit Card of Intermediate Sc / equivalent Examination.
 - iv. Certificate for Residence of Bihar duly issued by Concerned C.O. countersigned by DM/ SDO (Civil) of permanent residence.
 - v. Caste Certificate duly issued by Concerned C.O. countersigned by DM / SDO (Civil).
 - vi. All the Certificates in Original as per the requirements of the prospectus of UGMAC-2016.
 - vii. All the Certificates in original as per the requirements of para 4 & 5 of the Prospectus of UGMAC-2016 (if applicable).
 - viii. Six copies of the passport size Photograph which was pasted on the Admit Card NEET(UG)-2016.
 - Downloaded print of Online filled in Application Form (Part-A & Part-B) UGMAC-2016 processed as per para 3 of Adv. No. BCECE(BCECE)-2016/27 dt. 10.09.2016.
- 8. The candidates are required to bring all the certificates/documents as mentioned in para 2 & 5 above positively at the time of counselling otherwise they will not be eligible for admission.
- 9. Inclusion of any UGMAC-ID in the above Counselling reschedule programme does not guarantee admission. Since candidates

in excess of the available seats are being called for Counselling / Allotment in order to ensure filling up vacancies which may arise due to absentees, those having merit positions lower than the total number of sanctioned seats will be admitted subject to availability of seats.

- 10. (a) If the counselling does not complete on rescheduled date, the concerned candidates have to stay on the next day in order to complete it.
- (b) If the available seats are filled before the rescheduled date and time, the counselling will be postponed / discontinued.

 11. If a candidate called for Second Counselling / Allotment is found ineligible as per the requirements of the prospectus of UGMAC-2016 and / or the latest order/ orders passed by the Hon'ble High Court/ Supreme Court or Department of Health in matters related to UGMAC-2016, his / her candidature is liable to be rejected.
- 12. Each eligible candidate will be allowed to exercise his/ her option for Course/ Institution from amongst those available at his/ her merit serial after his/ her original Certificates/ Documents and identity are verified.
- 13. A candidate who absents or fails to appear on the scheduled date & time of his/ her Counselling/Allotment may appear for Counselling any time during the period of Counselling of his/her respective Reservation category, but in that case he/ she will have the option of Course/ Institution available at the time of his/ her actual reporting.
- 14. Each candidate should note that once the Course/ Institution is opted at the time of his/ her Counselling and the same is allotted to him/ her, no subsequent request for change of course and/ or Institution shall be entertained.
- 15. The vacancy position as on 26.09.2016 for 2nd Counselling can be seen on Board's Website. The available vacancies may change at the time of starting 2nd Counselling on 28.09.2016.
- 16. In case of dispute, decision of the Controller of Examination, BCECEB shall be final.
- 17. The Govt. of Bihar and the Bihar Combined Entrance Competitive Examination Board reserve the right to amend the rules relating to UGMAC-2016.
- 18. Any typographical error inspite of all precautions taken and detected any time shall be corrected whenever detected and merely publication of UGMAC-ID will not confer any right for admission.
