- 2. The Principals are requested to pay the examination fee for received application forms and not to pay the fee for un-received application forms. Any excess fees for un-received application forms is not refundable Individual demand drafts submitted by the students will not be accepted.
- 3. The Principals are requested to verify and forward all the Application forms immediately along with the Name List (Nominal Roll) in prescribed proforma, subject wise data & fee particulars in duplicate.
- 4. IMPORTANT NOTE: The concerned Principal's are requested to deposit (credit)/transfer the Consolidated Examination fee amount into "Registrar, Palamuru University Examination fee Fund A/c No: 62078258948 (SBI, Raichur Road Branch, Mahabubnagar, IFSC Code "SBHY0020982")" in any branch of State Bank of India through NEFT/RTGS and obtain a receipt from the bank and submit the same to the Examination Branch, PU along with application forms.
