**ONLINE APPLICATIONS ARE INVITED FOR EXTENSION OF PROVISIONAL
AFFILIATION INCLUDING SANCTION OF ADDITIONAL SECTIONS FOR THE
ACADEMIC YEAR 2021-2022.**

Applications are invited through online from the managements of existing Junior Colleges (including composite colleges) in the Telangana State for extension of Provisional Affiliation for the academic year 2021-2022 including sanction of Additional Sections if any over and above the permanent sections indicated in the Letter of Intent or Provisional Permission & Provisional Affiliation Order subject to a maximum of 7+2 sections in terms of G.O.Ms.No.12, dated:09-03-2002.

The managements are informed that the rates of affiliation fee, inspection fee & application fee (Form-II) are shown in online application form. Proposals for sanction of additional sections without providing additional accommodation as required will be summarily rejected. While submitting proposals for provisional affiliation and sanction of additional sections if any, the managements are requested to see that the FDR, Registered Lease Deed of the building and playground, Fire safety certificate, sanitary certificate and structural soundness certificate are in force for the period for which they have requested for extension of provisional affiliation etc. The fire safety certificate should be renewed as per the norms of the fire services department, otherwise, the proposals will not be considered. The college building should comply the norms given in GO.Ms.No.29, date: 24.09.2020.

All the colleges are informed that, the TSBIE will announce the list of affiliated Private Junior Colleges for the academic year 2021-2022 to the Public (students and parent's community) well in advance before the beginning of the academic year 2021-2022 and announcement of the admission schedule for the academic year 2021-2022 so that the parents and students gets ample time to enquire and confirm whether the college has affiliation for the academic year and which courses are sanctioned for the college it is made clear that without prior sanction, they should not open new sections. Any such deviation will be viewed seriously, and will make them liable for disaffiliation besides imposition of penalty under Telangana Education Act and the rules made under there.

Preceding academic year i.e., during 2020-2021 on the request of TPJMA the Hon'ble Education Minister has not enhanced the fee rates and agreed to implement the revised rates from the academic year 2021-2022. The details of enhanced affiliation and inspection fee for General and Vocational Junior Colleges is furnished underneath:

The managements are hereby requested to apply online in Form-II for extension of provisional affiliation including sanction of additional sections from the official website **tsbie.cgg.gov.in** of Telangana State Board of Intermediate Education with effect from **12.05.2021**. The application fee and prescribed inspection fee and affiliation fee should be paid together through online payment only. **Offline(manual) payments through demand drafts, Challans and submission of offline Form-II will not be accepted and summarily rejected.**

Requests for shifting of college premises, change of society, name change of junior college etc... should be made along with the affiliation proposals. After **05.07.2021**, the requests for the above will not considered under any circumstances. Hence, the managements of private un-aided junior colleges are requested to adhere to the above instructions scrupulously.

The last date for uploading applications along with necessary enclosures is **24.05.2021** without late fee. Further the time schedule is as follows.


